

The 2020 SRIA Annual Meeting will be held virtually this year. We hope that you will join us! Below is important information regarding the conference. Please be sure to complete and return your registration form as soon as possible.

**Cost:** For faculty or industry practitioners, the total cost of the meeting is \$100 (\$50 conference registration fee and \$50 Membership/JII fee). For PhD students, the total cost of the meeting is \$10.

**Meeting Goals:**

1. Give the PhD students actual presentation time via zoom
2. Ensure feedback on each presentation
3. Not Zoom everyone out with all papers being presented live

**Outline of Meeting Format:**

1. Each presenter will submit their 20-minute recorded presentation to Dropbox by Monday, November 23rd (i.e. the originally scheduled SRIA meeting date). Authors will receive a Dropbox link (via email) with instructions for uploading video.
2. A formal discussant will be assigned to each paper. Each discussant must post either their written comments or submit their 5-minute recorded comments to the presentation to Dropbox by Friday December 4th. Discussants will receive a Dropbox link (via email) with instructions for uploading video.
3. SRIA will ensure that the presentations and discussion videos in Dropbox will be available for viewership for at least 1 month following submission.
4. Four live zoom sessions will be scheduled (Early to mid-December)
  - a. The SRIA business meeting (30 minutes)
  - b. The PhD best paper session (1 hour)
  - c. Two PhD paper sessions (3 to 4 PhD student presentations) (1.5 hours)

The scheduling of the live sessions will occur once we pick the PhD best paper to determine the schedule of the recipient of that award. We will also survey the other PhD students to determine the best timing of the PhD session. Those sessions will be recorded and made available in Dropbox if you cannot attend live.

We hope that this type of schedule provides everyone the opportunity to gain some interaction with other Southern Riskers, without spending two full days on Zoom.
