*Hotel Reservations:* Please make your hotel reservations directly with the Nashville Omni Hotel by calling 1-800-843-6664 and mentioning the Southern Risk and Insurance Association. The conference rate is \$179 per night plus taxes for Sunday and Monday nights. Please note our rates are valid until Friday, October 20 at 5:00 p.m. All reservations must be guaranteed with a credit card or accompanied by a first night room deposit.

*Transportation:* If flying, Nashville is serviced by Nashville International Airport (airport code: BNA). If you do not rent a car, shuttle service is available from the airport. **Receptions:** As is tradition, there will be an opening reception Sunday evening. SRIA will again host a President's Reception on Monday evening. The reception will take place after the sessions conclude on Monday and will be open to all attendees.

Dress: In keeping with SRIA tradition, attire for all events at the meeting is business casual.

**Dues:** As we continue our joint sponsorship of the *Journal of Insurance Issues (JII)* with the Western Risk and Insurance Association, dues are now \$50 for members. This includes an online subscription to the *JII* with print copies available upon request. Graduate student members only pay for registration fees as SRIA and WRIA will subsidize the cost of the journal subscriptions. Overseas members requiring print copies are required to pay a \$15 surcharge for the increased mailing costs.

*Graduate Students:* The SRIA has additional benefits for doctoral students. First, all doctoral students attending the conference will receive a free subscription to the *JII* for 2017. Second, the "Harris Schlesinger Memorial Doctoral Research Award" created in 2010 and named in 2016 will once again be awarded. Graduate students who have proposals accepted are invited to submit a full paper for consideration. The paper is due by October 9th and the winner will be notified by October 30th. The award will be announced during breakfast on Monday.
